



## **DKV appoints Marco van Kalleveen Chief Executive Officer**

Van Kalleveen has extensive international management experience and proven expertise in the mobility and logistics sector. Most recently, Marco van Kalleveen was Chief Operating Officer and a member of the Board of LeasePlan, one of the world's leading vehicle leasing companies. Before, he was a Board member of TNT Express, the (formerly) listed global courier and express provider. He started his career as a management consultant at McKinsey & Company, where he became a partner in 2004. Marco van Kalleveen studied business
